

# Logasol SKS4.0 | SKN3.0 Solar Flat Plate Collector

## 10-Year Limited Warranty

Subject to the terms and conditions set forth below, Bosch Thermotechnology Corporation, Londonderry, New Hampshire ("BTC") hereby extends the following limited warranties to the original residential retail purchaser of its Buderus SKS4.0 or SKN3.0 Solar Flat Plate Collector ("Solar Collector").

### Limited Warranty for Buderus Logasol SKS 4.0 and SKN 3.0 Solar Flat Plate Collector

BTC warrants to the original residential retail purchaser of the Solar Collector that the Solar Collector shall remain free from defects in the workmanship and materials during proper use at the original installation, provided proper and yearly maintenance is carried out by a qualified heating contractor and provided, further, that the other conditions of this warranty are satisfied. Provided that this warranty has not otherwise been terminated, voided or reduced, if BTC, at its option, will repair or replace the defective part as it finds necessary in accordance with BTC then applicable warranty service procedures.

### General Terms and Conditions

This warranty is subject to the conditions that the Solar Collector must have been installed, maintained and repaired by a professional heating contractor whose principal occupation is the sale and installation of plumbing, heating and/or air conditioning equipment and that installation, maintenance and repair were performed in strict compliance with Buderus Installation and Servicing Instructions and Engineering manuals. This warranty extends only to the first residential retail purchaser of the Solar Collector and only while the Solar Collector is owned by that purchaser and remains at its original installation site in the United States or Canada. Change in ownership or relocation of the Solar Collector shall terminate this warranty without further notice.

### This warranty does not cover:

1. Components or parts that are part of the Solar Collector system but were not provided by BTC as a part of the solar collector system.
2. The workmanship of any installer. BTC disclaims and does not assume any liability of any nature for unsatisfactory performance caused by improper installation, repair or incompletely documented annually required maintenance.
3. Any costs for labor for removal, reinstallation, repair and replacement of the alleged defective component or part, transportation to BTC, if necessary, and any materials necessary to perform the repair or replacement.
4. Any Solar Collector that has a failure of malfunction resulting from improper or negligent operation, accident, abuse, freezing, misuse, unauthorized alteration or improper repair or maintenance.
5. Any conditions resulting from the introduction of harmful chemicals, caustic fluids, or liquids detrimental to copper tubing, including improperly applied or maintained heat transfer fluids or chlorinated pool or spa water.
6. Damage to the Solar Collector or any of its original components or parts caused by excessive temperatures or pressures, fuel or gas explosion, electrochemical reaction, water and air impurities, electrical failures, riots, insurrection or acts of God.
7. Any Solar Collector operated with non approved anti-freeze agents.
8. Any applications other than medium temperature (110 – 180 °F) water heating.
9. Any condensation or similar occurrence resulting from the normal intrusion of moisture into the collector.
10. Damage resulting from improperly maintained heat transfer fluid with a pH value of  $\leq 7$ .

IMPLIED WARRANTIES OF FITNESS FOR A PARTICULAR PURPOSE AND MERCHANTABILITY SHALL BE LIMITED TO THE DURATION OF THE EXPRESS WARRANTY SET FORTH ABOVE. WITH THE EXCEPTION OF ANY WARRANTIES IMPLIED BY STATE LAW, AS HEREBY LIMITED, THE FOREGOING EXPRESS WARRANTY IS EXCLUSIVE AND IN LIEU OF ALL OTHER WARRANTIES, GUARANTIES, AGREEMENTS, AND SIMILAR OBLIGATIONS OF BTC WITH RESPECT TO THE REPAIR OBLIGATIONS OF BTC WITH RESPECT TO THE REPAIR OR REPLACEMENT OF THE SOLAR COLLECTOR OR ANY COMPONENT OR PART OF THE SOLAR COLLECTOR ITSELF. BTC EXPRESSLY DISCLAIMS AND EXCLUDES ANY LIABILITY FOR CONSEQUENTIAL, INCIDENTAL, INDIRECT, PUNITIVE OR SPECIAL DAMAGES OF ANY KIND FOR BREACH OF ANY EXPRESS OR IMPLIED WARRANTY, INCLUDING, WITHOUT LIMITATION, INJURY OR DAMAGE TO PERSONS OR PROPERTY OR DAMAGES FOR LOSS OF USE, INCONVENIENCE OR LOSS OF TIME. BTC NEITHER ASSUMES NOR AUTHORIZES ANY OTHER PERSON TO ASSUME FOR BTC ANY LIABILITY OTHER THAN THE LIMITED LIABILITY SET FORTH HEREIN.

Some states do not allow the exclusion or limitation of incidental or consequential damages, or limitations on how long an implied warranty lasts, so the above limitations and exclusions may not apply to you.

If you are the first purchaser at retail, and the current owner, of the Solar Collector that is still located at the site of its original installation, and you think you are entitled to service under the foregoing warranty you should follow the following procedure:

1. Notify the heating contractor who installed your Solar Collector and ask that the contractor notify the distributor from whom the contractor purchased the Solar Collector.
2. If this action is not possible or does not result in warranty service, contact:

To support the warranty claim, include the following:

- a. A copy of your original invoice or other proof of purchase
  - b. Original installation date
  - c. Location
  - d. Serial number of the Solar Collector (rating label)
3. The alleged defective components or parts must be returned to BTC through trade channels in accordance with BTC's procedure then in force for handling goods returned for the purpose of inspection to determine cause of failure.
  4. If BTC determines that the returned components and/or parts are defective and that this warranty applies, BTC will furnish the repaired or replacement components and/or parts to an authorized Buderus distributor who, in turn, will forward the components and/or parts to the heating contractor who installed your Solar Collector.

This warranty gives you specific legal rights, and you may also have other rights, which vary from state to state.
